

## **Short-Term Payment Plan option**

To help make tuition payments manageable for students, CDU offers a short-term payment plan for students registered in a Term for 3 or more credits. The payment plan allows tuition to be spread out over three or four equal installments over the course of the term. There is a \$30 per course fee and this option is only available for online term courses.

If you would like to utilize the short-term payment plan option, please email the Bursar to request one. The Bursar will then send you a payment plan agreement detailing payment amounts and due dates for your approval. ALL PAYMENT PLANS MUST BE APPROVED BY THE BURSAR. Each month after registration, you will need to visit your Populi account to pay your monthly installments. Please note that your student ledger will show the full amount due. When making installment payments, you may adjust this amount manually to agree with your scheduled payment. The 12 week term course short-term payment plan is based on four equal payments of the current tuition. In addition, the first payment includes all additional fees such as technology fees and payment plan fees. The following are examples of payment plan schedules at the current tuition rates for a 3 credit course at both the undergraduate and graduate level.

The 8 week term course short-term payment plan is based on three equal payments of the current tuition. In addition, the first payment includes all additional fees such as technology fees and payment plan fees. The following are examples of payment plan schedules at the current tuition rates for a 3 credit course at both the undergraduate and graduate level.
